may be requested to leave an investigative	e site and possibly be dismissed from the
CRPT. I understand that my participation	on investigations is not guaranteed and
that I have the right to refuse to go on an i	nvestigation.

CRPT Code of Conduct:

- 1. I will conduct myself as a professional during all investigations and functions of the CRPT.
- 2. I will never harass or harm any CRPT member or other person(s) at any investigation or CRPT function.
- 3. I understand that I am to wear proper attire to all CRPT investigations and functions. Proper attire includes logo clothing, jeans, shorts and enclosed shoes. No shirts or hats with messages that may offend are allowed.
- 4. I understand that I am to follow the direction of the Lead Investigator at any CRPT investigation or function. If I feel that the direction given is not in accord with the CRPT Code of Conduct I understand that it is my responsibility to respectfully address the matter privately with the Lead Investigator.
- 5. I will not enter a building alone or leave another investigator in a building alone.
- 6. Neither violence or theft will be tolerated by the CRPT and engaging in either is cause for immediate termination from the team. The CRPT will cooperate in any legal action that may arise from such acts and any individual that engages in such activity will be solely and wholly responsible for any legal proceedings they may incur.
- 7. I understand that CRPT holds no responsibility to me if I am hurt during an investigation. If I am hurt by another team-member, I have the right to hold that person responsible for my injury.
- 8. I understand that I hold the rights to all photographs, videos, and voice recordings collected during an investigation and that I am held to the standards of the confidentiality agreement signed by the client. I agree to provide copies of original files to CRPT to be used for teaching and promotional purposes and understand that I will be given full credit for said files.
- 9. I agree to provide evidence files to the Lead Investigator within the specified time for all investigations.
- 10. I understand that an investigative report is expected from any investigation in which I am the lead and agree to complete same document.
- 11. The CRPT will not declare a location "haunted" until a full review of the evidence is completed and the team is in agreement that the activity is validated and paranormal in nature.
- 12. I understand that the CRPT does not claim the ability to rid an area of any possible entity or presence.
- 13. I understand that the safety of the client, team, and environment, as well as the integrity of the CRPT reputation are to be my main focus in all functions even if this means a potential loss of evidence.
